There are many benefits with a membership in APIC. APIC provides education through conferences, seminars and business meetings, professional support and practice guidance, reports on legislative and regulatory information, networking with colleagues, on-line information at the chapter and national websites (including a state and national ListServ), and much more.

- Potential members are invited to attend 2 local chapter meetings prior to joining.
- You need to join the National organization in order to join a local chapter. National APIC dues are \$180 annually. To join the APIC-SEW chapter include the \$10 chapter dues with your national dues (make sure you mark APIC-SEW, chapter 030 on the application). Membership is for individuals only.
- Your National membership includes a subscription to the *American Journal of Infection Control* and *APIC News*.
